- Reviewing and revising the syllabus on the basis of experiences on the transaction of curriculum and process of implementation has been an annual practice of the Institute. Each and every paper designed by the Faculty are reviewed

and revised in the light of classroom transactions and internal and external assessment and evaluation of the course run by the Institute.

- B.Sc.-B.Ed. IV year integrated program was redesigned in the year 2015-16. The revision was done on the basis of NCTE guidelines and teachers, students' feedback in workshop mode involving experts in the field of education; subject-specific, and pedagogy. The syllabus was developed with detailed outlines, frames, and integrated content with pedagogy. The suggestions obtained from fellow academics from other Institutions were also considered.
- Institute promotes ICT-enabled learning by providing e-content through various platforms such as YouTube channels, PM e-Vidhya, Swayam, etc.
- Institute ensures improvement in quality of education through different in-service and pre-service programs in the field of School Education and Teacher Education.
- 'In-service teachers' training/in-service teachers' professional development package had been developed to fulfill the educational need of different States & UTs of Northern Region.
- The assistance is provided for the implementation of different educational policies of the Government of India.
- The Institute with other units of NCERT provides support for the implementation of all centrally sponsored programs of MHRD.
- Institute encourages innovative practices in school and teacher education.
- The Institute organizes different learning experiences such as Pre-Internship, (field experience) Internship in Teaching, Art integrated learning field service, debates, seminar, sessional, project work so that teaching becomes reflective. In addition, each and every student teacher is given an opportunity to reflect on their own teaching by keeping the discussion with the cooperative teacher and Institute supervisor during Pre-lesson discussion and post-lesson discussion as well as their own classroom transaction.

Quality in Education

Efforts are made to ensure of improvement in quality of education through different in-service and pre-service programmes in the field of School Education and Teacher Education. The Institute, as a constituent unit of NCERT has been working in the field of Educational Research, Training and other Academic activities such as working paper on alternative ways of schooling, community participation, modules on on-line teachers training and guidelines for opening of schools during Covid-19 pandemic situations. Besides this, as NCERT has been entrusted by Ministry of Education to prepare National Curriculum Framework for School Education and providing its academic support to States and UTs for developing State Curriculum Framework, the Institute faculty members have been associated with different core groups to prepare NCF. Institute faculty is also engaged with NIE for tracking of learning outcomes prepared by NCERT as one of the prime concerns under quality Education initiative.

Quality sustenance & enhancement

The quality enhancement has been ensured with ET Lab, e-learning centres, smart-classrooms, continuous addition of learning resources in library, art integrated learning and fully residential internship programme in Navodaya Vidyalaya. Besides this, the Institute has been working in coloration with DIETs, SCERTs, IASEs and Department of Education of States and UTs of Northern Region. State Coordination Committee of RIE, Ajmer has been its one of the strongest organisational initiative to identify Educational needs and their effective implementation through various programmes. Keeping in view pandemic situation, the Institute faculty has actively participated in various programmes of NCERT, New Delhi and Ministry of Education, Govt. of India. Faculty member of RIE, Ajmer contributed in various documents and guidelines developed by NCERT such as Community Participation in school education, guidelines for reopening schools, guidelines for gifted children, question items for teachers and teacher educators on NEP 2020, supplementary learning material i.e. LOPAT etc.

Quality of School education

Organized workshops, national seminar and conferences to provide a common platform to all stake holders working in the field of school education and teacher education to share their experiences, researches, innovative practices and their impact in improving the quality of school education. Also to document the best practices and researches in the field of education. The Ministry of Education, Govt. of India has launched a nationwide holistic advancement programme of School Heads and Teachers under the NISHTHA 3.0 being organised through online mode in all the States and UTs. The faculty member of Institute has worked as National Resource Group Member for developing online NISHTHA training module. The NCERT had developed a comprehensive and integrated NISHTHA module in 2019 for which RIE, Ajmer faculty worked as contributors.

Quality of Curriculum

The Institute has already developed Choice Based Credit System (CBCS) of two years M. Ed Programme, two years B. Ed. Programme, four year integrated B.Sc. B.Ed. Programme and four year

integrated B.A. B. Ed. Programme. These pre- service programmes are affiliated to MDS University, Ajmer.

Quality of Teaching & Learning

The Institute has focused on Quality Teaching Learning for its various Pre-service programme of M.Ed., B.Ed., B.Sc.B.Ed. and B.A.B.Ed. by supporting theory component with effective ICT based audio visual programmes. The practical component of aforesaid programmes has been effectively addressed by different activities such as working with Community Programme, workshop on Yoga, health and well being Art and Aesthetic. Besides this, keeping in view pandemic situation and closure of schools, the Institute has planned to organise Pre-Internship, Internship and field attachment of pupil teachers through online mode in collaboration with private schools, KVs, NVS, CTE and IASE in order to fulfil the requirement of syllabus. It has been an innovative practice to ensure Quality of Teaching Learning. Furthermore, the Institute has a well established e-learning centre and studio to support scholastic and co-scholastic activities of the pre-service programmes. This year Institute has prepared quality video programmes for PM eVIDYA portal.

Examination & Evaluation

The Institute is affiliated to MDS University, Ajmer, therefore, examination followed by declaration of result and award of degree comes under the control of University. The Institute has taken initiatives to make examination system more comprehensive and quality based as two internal tests are conducted for the pre-service students followed by individual/group assignments. Co-scholastic areas of learning are also evaluated through in-house activities of the Institute including games and sports, literary and cultural activities. The performance of the faculty and other staff is assessed through annual self appraisal reports. The evaluation of self appraisals are reflected in teaching learning strategies, undertaking research and motivating faculty and other staff for better performance. During the session 2020-2021 the Institute has conducted its Internal Examination, Orientation for Internship and Pre-Internship Programme, workshop on Art and Aesthetics and working with Community programme through online mode. Evaluation and Assessment of students done by faculty of Institute on the basis of students' online participation and assignment submission.

Research & Development

The App has all the information related to the study such as vision, mission and objectives of study, name of schools covered with details of student and teachers, research methodology adopted for the study, baseline achievement assessment and analysis of students, interventions modules, Art Integrated Learning (AIL) activities of the block and details of interventions implemented. The teachers of the block are being benefitted by the app by exploring the resource material. The APP is also a sharing platform for peer learning and projecting their activities.
- Career guidance and counselling awareness programme for the rural school students, teachers and parents: To provide awareness and exposure to rural school students, teachers and parents about the various career options, the institute is organizing career guidance and counselling exhibition in rural schools of Hurda block of Bhilwara district. The exhibition gives opportunity to the students and parents of

the block in guidance and counselling for planning future studies. The exhibition also benefited the institutes' Diploma Career Guidance and Counselling (DCGC) students to have real experience of interaction and demonstration, and presentation on the theme based situations.

- Institute students working with community programme: The institute organized working with community programme online with the aim to orient students towards community sensitization for retention, enrolment and regular attendance of the village children in the schools and to make them aware, about the various schemes of government related to education particularly school education. One of the objectives of the programme is to provide a platform for students for demonstrating the activities for establishing the link with community, interaction with various community stakeholders (like parents, villagers, SMC/SDMC members) along with teachers and students.

7.3 - Institutional Distinctiveness

7.3.1 - Highlight the performance of the institution in an area distinct to its priority and thrust (within a maximum of 200 words)

Bringing quality improvement in the teaching-learning process in schools and progress in learning as well as overall development of the learners has been the core of the functioning of NCERT. To achieve the desired goal, several research, development, training and capacity building programmes of teachers and teacher educators and extension activities at the macro (regional and district) level are conducted every year. To study the implementation of interventions at a micro level and to find its' effectiveness, the Regional Institute of Education, Ajmer has taken up a research programme in one of the blocks of states of Northern Region.

For implementing need-based interventions at block level and to see its effectiveness, the institute has conducted a research study in 167 schools including 83 Primary, 54 Upper primary, 6

Secondary and 24 Senior Secondary schools involving 5 Sanskrit Pathashalas and 5 Madarsa of Hurda Block of Bhilwara District of Rajasthan in the year 2018-19 and 2019-20. The block has been selected on the basis of poor performance of district in the NAS 2017.

On the basis of the assessed learning levels of students and teachers' need assessment data, the need-based interventions (training and onsite support) have been planned. It has been planned strategically that for improving learning outcomes, the quality interventions will be imparted using Art Integrated Learning (AIL) and School Based Assessment (SBA). The capacity building programme for the teachers and head teachers in the block, based on the low performing learning outcomes of students indicated by the baseline assessment focused on improving learning outcomes in school subjects through Art Integrated Learning (AIL) and School Based Assessment have been organized. For providing the onsite support to the teachers and promoting peer learning, 2 teachers from each Panchayat have been identified and trained as master trainers on attaining Learning Outcomes through "Art Integrated Learning".

The follow-up, onsite support and continuous mentoring of quality interventions are being provided by a team of faculty of institute by providing the onsite support and continuous monitoring in collaboration with PEEOs and master trainers. The onsite academic support or input to students and teachers of the assigned schools are being imparted by observing the classroom processes. The institute faculty is establishing rapport and personal dialogue with different stakeholders in the school (CBEO, PEEO, SMC/ SDMC, teacher and parents) and demonstrating suitable solution to the problems/ difficulties faced by the schools in imparting the planned interventions. Besides onsite support, the faculty members are also conducting case studies to find out the effect of implemented interventions on the learning levels of the students and also on the classroom process of schools. The interventions are also being implemented through following alternative strategies.

- Providing platform for learning and sharing experiences.
- Promoting teacher circles on Art Integrated Learning for Peer-learning.
- Community Sensitization & Engagement by working with community programme and organizing career counselling exhibition (September, 2021)
- Monitoring, follow-up and interaction with various school

stakeholders by Core Team of NCERT.
