Fig. 1: Year wise analysis report of feedback received from students.

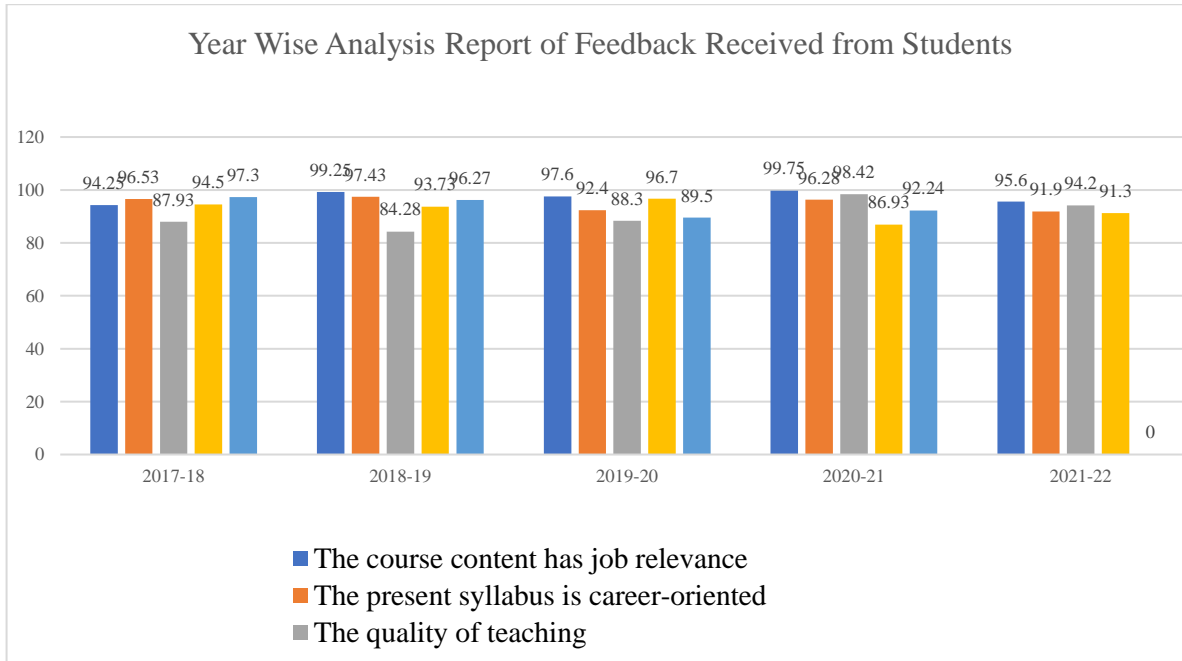
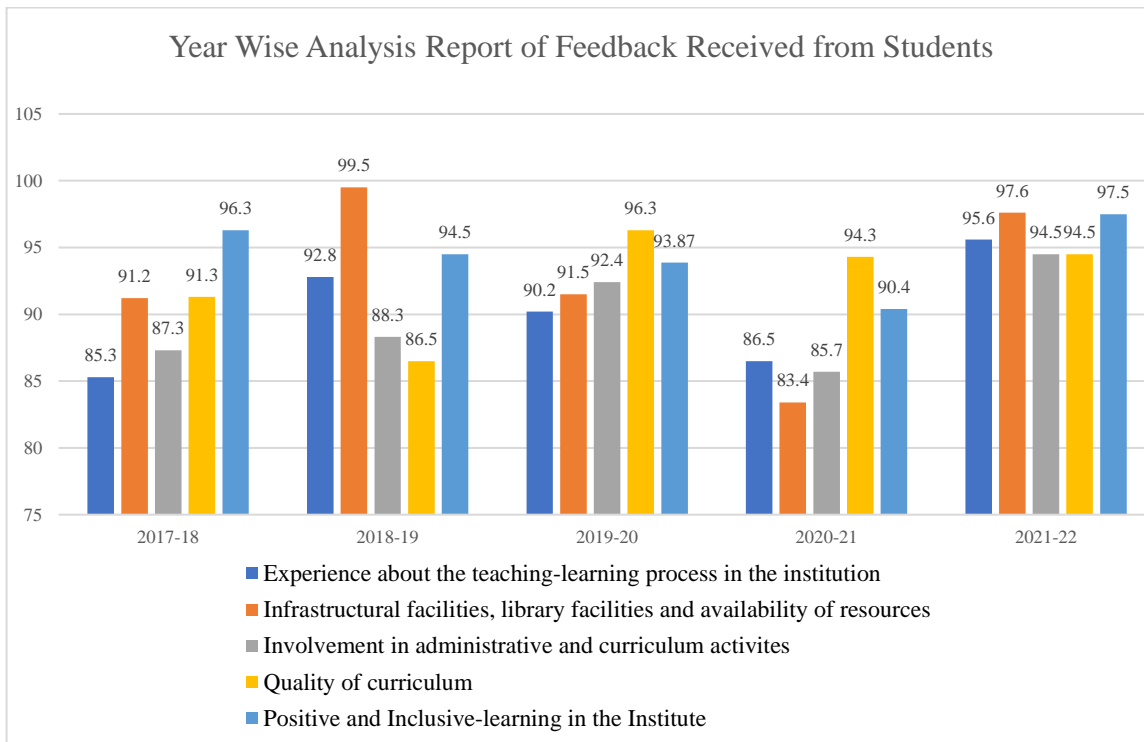


Fig. 2: Year wise analysis report of feedback received from teachers.
