## Minutes of the Meeting

In reference to Notice No.F.1-3/PA/2022/ dated 01.04.2022, a meeting of Internal Quality Assurance Cell (IOAC) of faculty and staff of this Institute was held on 1st April, 2022 at 04:00 PM in room no. 102 to discuss various aspect related to the activities, preparation and finalization of Annual Quality Assurance Report (AQAR) for the session 2021-22. The meeting was chaired by the Principal and Chairperson IQAC, Prof. S.V. Sharma along with Dean of Instructions and Coordinator, IQAC Prof. Rajesh Mishra of the Institute. The meeting was attended by faculty members/officials (as per the Criterion wise committees) attended the meeting.

Meeting commenced with welcome of all the members. Consolidated information pertaining to different criteria (criterion-I, II, III, IV, V, VI & VII) filled in prescribed performa of the Annual Quality Assurance Report (AQAR) submitted by the faculty members as per details furnished in earlier notice was circulated to the members. Each criterion of the AQAR was discussed and deliberated. In the light of discussion /suggestion, the faculty members were requested to do the needful as per discussion and suggestion to their respective criteria. It was also requested that they should send the complete filled in and checked performa of AQAR along with the creation of online links and additional documents for uploading regarding various criterion as soon as possible, so that the report of AQAR can be finalized and uploaded to NAAC. Along with this, discussions and deliberations were also made with respect to activities of NSS and Students' Council. Amendments in PAC programme proposals for the year 2022-23 were discussed and programme coordinators were requested to submit their respective finalized proposals as suggested in 59th meeting of PAC of NCERT held at NCERT, New Delhi.

The Principal and Chairperson, IQAC emphasised upon the justified need for reaccreditation of the Institute by NAAC as this session will hold the second cycle of the accreditation. He insisted on the timely submission of the AQAR for the current session 2021-22 and requested all the concerned to do the needful in time.

The meeting ended with a vote of thanks to the chair.
