Essential Qualification for Medical Officer (Part-time) :

1. MBBS (Higher qualification would be preferred)
2. Should be a registered Medical Practitioner in Rajasthan
3. **Experience :** Must have worked in a reputed Nursing Home/Hospital/Govt. Dispensary as a Medical Officer for at least 3 years.
4. **Tenure of appointment:** One year.
5. **Duty hours :** 09:00 AM to 12:00 noon for Medical Officer to be engaged for Morning session & 03:00 PM to 06:00 PM for Medical Officer to be engaged for Evening session, 6 days in a week from Monday to Saturday.

Essential Qualification for Compounder (Female) :

1. Three year Diploma in G.N.M. Course and preference will be given to registered Pharmacist.
 2. Working experience at least 3 years
- Age Limit - Below 30 years as on 14-03-2018.

Essential Qualification for Storekeeper Gr.-II :-

1. Must have passed 12th Standard or equivalent examination from a recognized Board.
2. Certificate/Diploma in Store Keeping and Purchasing
3. 03 years experience of procurement/Inspection Maintenance and verification of Stores in a Govt./Semi-Govt. organization or a Private Organization of repute.
4. Retired Govt. employee below 62 years of age on the date of interview and having 03 years experience as Store Keeper can also apply.

Note: Retired Govt. employees from the Stores will be preferred

Essential Qualification for Hindi Translator :

Essential

Master's degree of a recognized University in Hindi with English as compulsory or elective subject or as the medium of examination at the degree level.

OR

Master's degree of a recognized University in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level

AND

Recognized diploma or certificate course in translation from Hindi to English and vice-versa or two years experience of work from Hindi to English vice-versa in central and state government office including Government of India undertaking.

Note 1: Qualifications are Relaxable at the discretion of the Competent Authority in the case of candidates otherwise well qualified.

Note 2: The qualification (s) regarding experience is Relaxable at the Competent Authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.

Age Limit - Below 30 years as on 14-03-2018

Candidates who fulfill the above eligibility conditions may attend the walk-in-interview with their application in the following format with a recent passport size photograph and original testimonials, proof of age, caste certificate in r/o SC/ST/OBC and produce a set of self attested copies of testimonials for scrutiny one hour before the commencement of the interview.
