
1. IQAC Activities: Submission of AQAR and process of reaccreditation by NAAC - 10 June, 2022.



For the submission of AQAR of session 2021-22, each criterion of the AQAR was discussed and deliberated in length. In view of the suggestions provided by the faculty members, all were requested to do the needful as per their respective criteria. It was also requested that the submission of the said report should be completed in time bound manner, so that the report can be finalized and uploaded to NAAC portal. Along with this, discussions and deliberations were also made regarding preparation of SAR in phased out manner vizually 30.06.2022 I draft, 15.07.2022 II draft and 31.07.2022 III draft. Application for ITEP (Integrated Teacher Education Programme) pilot project to NCTE (National Council for Teacher Education) was discussed and the increase in intake in compliance with action point vide NCERT's communication.


The meeting ended with a vote of thanks to the chair.


